



December 2016

Guest Speaker

Carmen Cognetta gave a presentation on the election results, analyzing the swing districts on Staten Island and also spoke about strategies for winning future elections. Mr. Cognetta compared the results from the 2008, 2012 and 2016 Presidential elections both nationally and locally. He also spoke about the Electoral College. He also mentioned that fewer people came out to vote for this election than the last time. Mr. Cognetta also spoke about how the country has historically alternated between voting for Democratic and Republican Presidents.

He also explained that national security, the economy and social issues at the time influence the way people vote. Mr. Cognetta explained that people look at government as the problem not the solution and he added that the Democratic candidate didn't really have a clear message or clear positions on issues.

Steve Harrison on the Electoral College

S.I.D.A. member and former Congressional candidate Steve Harrison will speak at our December General Membership Meeting about repealing the Electoral College. He submitted the following statement for publication in the newsletter.


The Electoral College - Undemocratic Now; Undemocratic Always

In 2000 Al Gore lost the presidency but won the popular vote by 540,000 votes. Why? The electoral college system.

This year Hillary lost the presidency but is closing on winning the popular vote by 2.5 million votes. Why? Again because of the electoral college system.

This means that in twelve of the twenty years from 2001 thru 2020 America will have been ruled by a minority president, i.e., a president who was rejected by a majority of Americans.

This anti-democratic system must stop because quite simply -



its not democratic. We need a constitutional amendment. So let's start working toward one.

A good explanation of the rationale for the electoral college as adopted by our forefathers is given in Factcheck.org.

In sum, contrary to what many believe, the E.C. was not intended to balance power between populous states and small ones. That problem was brilliantly handled in the constitution by the establishment of a two-chamber congress. Representation in the House is proportionate to the population of each State. Obviously, the smaller states are overwhelmed in the House by the larger ones. But the Constitution mandates only two Senators from each State regardless of size. So Wyoming, with 1 representative in the House, nevertheless has two Senators, the same as California which has 53 representatives. To a degree, this scheme gives the smaller states the ability to veto overarching legislation favored by the larger States but potentially detrimental to the smaller ones. But it also allows the majority of the populace to thwart unpopular actions of a majority of States that represent a minority of the population.

In contrast, the E.C., used to elect a president, has nothing to do with the big state/little state issue. The E.C. is actually rooted in white male elitism and racism. It was actually designed as a check on democracy because the founders - all white men- did not trust the rag-tag population to elect the president. According to Hamilton, the EC was designed to ensure that the president is chosen "by men most capable of analyzing the qualities adapted to" a president. In other words the voice of the populace is, at best, advisory. The E.C. system was only designed to preserve

"the sense of the people" for consideration by the electors. But each elector was free to choose as HE pleased.

Each state chooses how its electors are appointed. Now all but 2, Maine and Nebraska mandate that the candidate with the most votes in that State gets all the electors. But that does not make the electoral votes proportionate among the States because the number of electors in a State is equal to the number of senators plus the number of representatives. So California gets 55 electors (2 senators plus 53 reps) and Alaska gets 3 (2 senators plus 1 rep). But that works out to 1 elector for each 244,000 citizens in Alaska and only 1 for each 735,000 in California. In short, in a presidential election, each Alaskan has three times the voting power of each Californian. Why? Because the number of Senators is constant across the Board, so the larger the State the smaller its voting power in the electoral college. I for one believe my vote should count as much as any other American. After all, if one person one vote means anything it must mean that.

This atrocity must change because it is a sin against democracy. It is an insult to all Americans.

I am aware that a constitutional amendment has been proposed before and rejected. But that's because the roots of the electoral college have been misunderstood as a search for democratic balance between the States rather than the elitist power grab that it actually was.

I am also aware that of the NPVIC (National Popular Vote Interstate Compact). Wikipedia has a good article on this. This is a legislative effort to "circumvent" the constitution. Each State that joins the pact - 11 so far - agrees to award all its electoral votes to the winner of the NATIONAL popular vote. Currently almost all States award the electoral votes to the winner of the STATE's popular vote. Once the number of States in the pact reaches a total of 270 electoral votes (they have 165 so far) then it can, theoretically, be guaranteed that the winner of the national popular vote will win the election. Sounds great, right?

Not so fast.

The problem is the NPVIC may be (and I believe it is likely to be) unconstitutional. If it is challenged in the Supreme Court and declared unconstitutional, a lot of effort will have gone for naught. Moreover, even the advocates agree it is intended to circumvent the constitution. Is such a strategy wise as a matter of policy? Does it open the door for other policies to "circumvent" constitutional provisions we cherish, say, freedom of speech, the right to counsel, or the prohibition against cruel and unusual punishment? It raises the question. Do we believe in the Constitution or not?
